Information entered by filer as a memo:

On January 6, 2023, Bank of America (BOA) issued a credit reversal for \$900.00. I originally deposited a \$900.00 check in an ATM machine on November 15, 2022. This donation which I had accepted, came from the Canyon Lake Republican Women's Club PAC (CLRWC). That deposit was apparently lost by the bank and did not show up as a deposit in the ATM machine. I reported this \$900.00 campaign donation in the January 2023 Campaign Finance Report. BOA issued a temporary credit on November 15, 2022, and conducted an investigation about this deposit. At the end of the investigation, BOA was unable to find the check I deposited. Then the bank reversed the temporary credit on January 6, 2023. Therefore, I am reporting this reversal as a campaign expenditure in this July 2023 Campaign Finance Report. I notified CLRWC. They stopped payment on the first check and issued me another check in the amount of \$900.00 which I accepted and deposited on January 27, 2023. By making this memo, it should clarify and timeline issues between my campaign finance reporting and CLRWC PAC reporting.
