**6 EXPLANATION OF CORRECTION**

The attached JCOH report for the 03/30/23 thru 06/30/23 reporting period reflects the corrected reporting of itemized expenditures.

Multiple attempts to upload an "expends" spreadsheet to the T.E.C. system were repeatedly undertaken. Each time the attempt was made an error report showed that the file was ineligible to be uploaded to the T.E.C. but no specific errors were identified.

Finally, when it was near the deadline, a decision was made to include the total expenditures as unitemized with the intention of working with T.E.C.'s technical support to identify the cause of the upload failure and take the necessary steps to upload the data.

In addition, job titles have been included for all individual contributors, along with some corrections to contributor's occupation and employer/law firm.
