7 EXPLANATION OF CORRECTION

As I was filing the current July TEC report, I had an epiphany and realized that I have been incorrectly filing a balance line item; a true and honest mistake. This correction now accurately reflects the correct contribution balance that was maintained as of the last day of this reporting period.

I sincerely apologize for the error on my part as, again, it was not made intentionally. This has been quite the learning experience for me as this is a volunteer position, one of many that I have for the Texas State Rifle Association. I am now confident moving forward, with future reports, that I have a better understanding of what is required to ensure an accurate report. I thank you in advance for your understanding.
