 4) In addition, I am the Republican Club's treasurer; I had problems filing that report and called the Commission, received a call back that day from Bill Wilson, he was very helpful in helping me complete that report filing successfully; if I had any idea the earlier report, for the Party, had not been released properly I would have asked how to make that filing; however, I thought the Party's report was filed properly.
