 1) Errors were discovered in two previously submitted reports on 12/11. Change of treasurer appointment was submitted on this date 12/11, and the process of correcting these reports started. On this report, missing was one contribution and one political expenditure, as well as a political expenditure that had the wrong name. This has been corrected.  
 We have changed Treasurer as of 12/11 and are in the process of hiring a compliance firm to assist with future filings anticipated to start in January. We did not receive filed reports from former treasurer and were unaware we could look them up online. Please consider waiver of penalties if applicable as we are a new GPAC and in the process of fixing compliance issues.
