Information entered by filer as a memo:

At the beginning of my judicial service I opened a campaign account. I deposited my own personal funds for payment of filing fees, as personal loans to the campaign, in that account. I paid for my filing fees for the 2016 and 2020 elections out of those loans to the campaign. I left \$100 in my campaign account, representing money I loaned my campaign but which was not used for filing fees. I never accepted campaign contributions. I had no campaign expenditures other than the filing fees. I retired Dec. 31, 2024, and I will not be running for office again. I plan to work as a senior judge accepting assignment from time to time. I will be repaying the above \$100 to myself, and I will close my campaign account.
