Our Upshur County Republican Party (RPUC) Executive Committee Treasurer died in late December 2024 and I was elected the new Treasurer effective December 31, 2024. I filed the ACECTA FORM mailed on December 31, 2024.

The County took corporate funds in 2020 and none since that time. My reconstruction of the records indicate all corporate donations were spent in the same year they were received on Lincoln Day expenses and the cost of sending our delegates to the State Convention. Our previous treasure's last report in September 2024 indicated we had \$618.82 remaining of co-mingled corporate funds. All or RPUC accounts were reduced to zero in December 2024 and the funds spent on administrative expense.

The enclosed January 15, 2025 PTY-CORP Report is our last required report. I talked with Seth at your legal hotline and he could not find a form to show this is a final report.
