6 EXPLANATION OF CORRECTION

The COH Campaign Finance Report covering January 1, 2025, through June 30, 2025, was timely filed. It was brought to our attention today that a Contribution was reported as being made on June 20, 2025. Our contribution platform ("Anedot") had been "Paused" from December 14, 2024 through June 23, 2025, and thus could not have accepted contributions until June 23, 2025, after the Moratorium ended. This correction is being made to correct a typographical error of "June 20, 2025", to the correct date of "June 23, 2025". We have definitive documentation that can be submitted from Anedot and Pinnacle Bank if needed. This error was an accident and was not intentional. We discovered this error today, July 29, 2025, and this correction is being filed today to include the correct date. The report as originally filed was in substantial compliance with the law.
