6 EXPLANATION OF CORRECTION

After the March Primary, I reviewed my 30-Day Report. I discovered some changes that needed to be made. In the Monetary Political Contributions section, I discovered some names were transposed according to the form (first name listed as last). I also added some information on the employment of a few of the donors giving additional information. The full details of those corrections are listed below.

At the time of submission, I was aware of Mike Wynne's donation. This was an online donation. My campaign account received \$1,000 in donation from Mr. Wynne. The online service company charged a processing fee of \$82.13. Mr. Wynne also paid the \$82.13 processing fee in addition to his \$1,000 donation.

I have refunded the \$82.13 out of the political funds account for the online processing fee Mr. Wynne paid. I provided Mr. Wynne with a letter explaining the refund and receipt of those funds has been acknowledged. In my July 15th Quarterly Campaign Finance Report, I will report the online processing fee that was refunded to Mr. Wynne as an expense in the Political Expenditures from Political Contributions section. Prior to taking that action, I contacted a supervisor at the Texas Ethics Commission and also its legal department to confirm this is the proper procedure.

The corrected information is as follows:

- Last and First names of 6 donors were transposed as indicated on the form including Cameron Riddels, Charles Wilcox, Karla McDonald, Laura Wheeler, Mark Russell, and Sherry Thompson.
- Employment information for Karla McDonald was updated to reflect Mayor of Howe, TX and Counselor at Stonebridge Family Counseling.
- Laura Wheeler's title was corrected as Mrs. She is a widow.
